Sh. S.S. Gill, IAS, Director (TTE/HE), GNCTD, Sh. Sunny C.K., DFO, IGDTUW and Sh. PVSS Subbarao, AFO, IGDTUW attended the meeting as special invitees.

At the outset, the Vice-Chancellor welcomed the Hon'ble Chairperson Prof. R.K. Kale and other distinguished members of the Finance Committee and also made a brief presentation about the various initiatives and achievements of the University during last one year. Some of the initiatives/achievements presented during the meeting were conduct of the first Convocation of the University, celebration of Technical Fest, Cultural Fest and Sports meet, starting of the M. Plan (Urban Planning), Bachelor of Business Administration (BBA) and M. Tech. programmes and Excellent Placement statistics with high pay package. The Committee was also apprised that Anveshan Foundation (an incubation and innovation center of IGDTUW) has received recognition from Department of Science & Technology (DST, Government of India as "Technology Business Incubator" and also the University has been selected by the Department of Science and Technology (DST) for establishing Center of Excellence in Artificial Intelligence and in first phase a grant of Rs. 35 Lakhs has been received by the University. The University has received Notable Mention Award from AICTE and Best Women Engineering Award from ISTE. Besides this, the University has signed MOU with CISCO, Nasscom, EATON, Cyber Peace Foundation, NPTU Taiwan etc. It was also informed to the Committee that DGEHS facility has been extended to all staff members of IGDTUW from 1st April, 2019.
