- v. Timely Evaluation of answer sheets by Evaluators.
- vi. Rechecking/Re-totalling of answer sheets.
- vii. Preparation of Award Lists.
- viii. Data Entry Operations.
- ix. Other necessary works for completion of evaluation Process.
- x. As per the CBCS Regulation of Examination Division. IGDTUW, the end term answer sheets for all the students admitted into academic session Aug, 2019 onwards must be shown to the students as per the date notified by the CS, Evaluation, Dec 2019.
